N.I.W.A. RECYCLING PROGRAM

Some helpful tips

We have sent our second box of ink cartridges to Ecycle Group that you have generously donated to the Club as a fund raiser. We have also sent in some cell phones. We appreciate your participation in this.

Ecycle Group will take inkjet cartridges from several brands as well as the larger laser/toner cartridges. They take used cell phones also.

Inkjet models vary in size and shape. All have a few components: a plastic body to hold the ink; flex tape with micro-circuitry; a printer nozzle; and a label showing the original manufacturer's name or logo.

We can accept both "virgin cartridges", that is, those that have not previously been refilled and "nonvirgin cartridges" (ie; Office Max; NuKote; Staples; Office Max, etc.). We get paid much better for the virgin cartridges, but will take them all. It all helps.

Here are the most common signs that an inkjet cartridge is non-virgin:

- 1. There is no manufacturer's label or one other than the original
- 2. The cartridge body or cap has a hole drilled into it
- 3. There is evidence that the cartridge cap has been removed.

We get paid more for the virgin cartridges.

Inkjet cartridges are unacceptable if damaged in one of the following ways:

- 1. There are small chips or cracks or excessive scratches in the ink tank
- 2. The circuit tape is cracked, bubbled, peeling, or has sharp dents in it.
- 3. The inkjet plate is gouged, scratched, or missing

Toner cartridges are the size of a small loaf of bread. They are used in printers, fax and copy machines. Ecycle does not accept any remanufactured toner cartridges.

Toner cartridges are much easier to inspect. If they have the original manufacturer's label, and do not show any signs of physical damage, they are probably good.

Cell phones have to be in working condition. Acceptable cell phones will not be crushed; water damaged or have broken LCD's. Cases should be complete and unbroken. Each cell phone must have a valid Serial Number. Please include the battery and any accessories, such as chargers or ear pieces.

Keep this reference before you submit a cartridge or cell phone. It will eliminate extra handling of unacceptable cartridges. If there is any doubt in your mind of the condition, just submit it and I will take it from there. It will help tremendously if you would bag or wrap each cartridge separately when submitting to me to protect each one from damage.

These are guidelines and hopefully they will help to clarify the program for you. We appreciate your help and cooperation and, most importantly, your continued support in helping the club to raise funds to further our educational goals in woodworking.


The manual is 12 pages long. It lists the basic technical data such as power rating and wattage. It lists a customer service number and website. It provides a parts list and exploded diagram, It provides the warranty information. It ONLY provides 3 LINES of operating information with NO information about the attachments. OH YEAH - It also provides 7 ½ pages of safety instructions – YES 7 ½ pages (such as - Don't operate this tool under the influence of drugs). 


HUMOR

HOW HARDWOOD LUMBER IS SIZED

Unlike dimension lumber, which is milled to industry-established nominal thicknesses, widths, and lengths, most cabinet-quality stock comes in random widths and lengths to keep waste to an absolute minimum. In addition, because all furniture and other woodworking projects have different dimensions, there's no need for dimensioned stock.

Thickness, though, has been standardized, and is expressed in different ways, such as 4/4 (1"), 5/4 (1 1/4"), 6/4 (1 1/2"), and so on. Don't be confused by all this; just remember that the quarter designation and the nominal thickness are the same animal.

When you order cabinet-quality lumber, you'll receive a board as long as or longer than and as wide as or wider than the item ordered. The thickness (if surfaced) will be close to that listed in the chart. When you purchase hardwood lumber, you buy it by the board foot. Even if the dealer has the boards already priced, he arrived at those prices by first figuring the number of board feet each contained.

A board foot, simply, equals 144 cubic inches of wood. Think of it as a piece 1 inch thick and 12 inches square. Because board footage always is calculated in quarters of an inch thickness, starting at no less than 1 inch (even if you order less than 1 inch, you'll pay for the 1-inch thickness), a 5/4 board 6 inches wide and 72 inches long would be figured like this: 1.25 (thickness) x 6 (width) x 72 (length) = 540. Divide 540 by 144 to determine the number of board feet in the stock. If the board length is stated in feet rather than inches, use the same method but divide your total by 12 instead of 144.
